Recall Description

THE SUPPLIER MAY HAVE APPLIED INSUFFICIENT ANTI-CORROSION TREATMENT TO THE OUTER TUBE OF THE LIFT GATE GAS SPRING. THE LIFT GATE GAS SPRING PROVIDES LIFTING ASSISTANCE FOR THE LIFT GATE AND OPERATES UTILIZING HIGH PRESSURE GAS. IF INSUFFICIENT ANTI-CORROSION COATING IS APPLIED TO THE OUTER TUBE OF THE GAS SPRING, IT IS POSSIBLE FOR THE OUTER TUBE TO CORRODE OVER TIME DUE TO SALT AND WATER PENETRATION. IF THIS OCCURS, IT IS POSSIBLE FOR THE GAS SPRING TO RAPIDLY LOSE PRESSURE.

Remedy

WNERS OF ALL AFFECTED VEHICLES WILL BE NOTIFIED AND ENCOURAGED TO BRING THEIR VEHICLES IN TO REPLACE THE LIFT GATE GAS SPRING WITH THE COUNTERMEASURE ONE. I

DUE TO INAPPROPRIATE MANUFACTURING PROCESSES INVOLVING CERTAIN COMPONENTS USED INSIDE THE DOOR LATCH, CERTAIN DIMENSIONS OF THESE COMPONENTS MAY BE OUT OF SPECIFICATION. AS A RESULT, THE DOOR LATCH MECHANISM MAY NOT SECURELY LATCH IN HIGH TEMPERATURE CONDITIONS. DUE TO AN INAPPROPRIATE MAINTENANCE PROCEDURE USED ON A WELDING MACHINE AT A RELAY SUPPLIER, WELDING OF COMPONENTS WITHIN THE RELAY MAY HAVE BEEN PERFORMED INCORRECTLY RESULTING IN IMPROPER ELECTRICAL CONDUCTION. AS A RESULT, ONE OF

Recall Description

IN THE EVENT THAT WATER DROPS DOWN THROUGH THE BACK SIDE OF THE FRONT DECK GARNISH (THE BODY PIECE BETWEEN THE HOOD AND WINDSHIELD), THE FRONT WIPER LINK BALL JOINT MAY EXPERIENCE EXCESSIVE MOISTURE AND CORRODE. IF THIS OCCURS, THE RESIN CASE OF THE BALL JOINT WILL WEAR PREMATURELY DUE TO THE BALL JOINT CORROSION AND THE WIPER LINK MAY ULTIMATELY SEPARATE CAUSING THE WINDSHIELD WIPERS TO STOP OPERATING.

Remedy

WNERS OF ALL AFFECTED VEHICLES WILL BE NOTIFIED AND ENCOURAGED TO BRING THEIR VEHICLES IN TO REPLACE THE ROD OF WIPER LINK WITH A COUNTERMEASURE UNIT. THE WIPER MOTOR CRANK ARM WILL ALSO BE REPLACED WITH NEW ONE. THE REPAIR WILL BE PERFORMED AT NO CHARGE TO THE VEHICLE OWNERS. THE INSIDE AND OUTSIDE SURFACES OF THE FRONT CROSS MEMBERS USED ON CERTAIN VEHICLES, IF EXPOSED LONG TERM TO SNOWMELT WATER AND ANTI-FREEZING AGENTS, MAY CORRODE DUE TO INSUFFICIENT PERFORMANCE OF THE RUST PROTECTION. SHOULD SIGNIFICANT CORROSION OCCUR OVER TIME, A LOWER CONTROL ARM COULD EVENTUALLY BECOME DETACHED RESULTING IN LOSS OF VEHICLE CONTROL AND A POTENTIAL COLLISION.

Remedy
