Recall Description

The affected vehicles are equipped with a Takata-sourced passenger side frontal airbag that may be susceptible to moisture intrusion. Over time that could cause the inflator to rupture when the passenger's frontal airbag deploys in a crash.

Remedy

Subaru will replace either the inflator or the airbag module for the front passenger airbag assembly at no cost to the customer.

Recall #: WUE-90 | Brake Light Switch Recall Date: 2019 Mar 01

Recall Description

On certain vehicles the brake lamp switch could fail. This would cause the brake lamps not to turn on when the brakes are applied. Depending on the model this could cause an inability to shift from park or to start using the push-button ignition. This may also cause problems with the following: anti-lock brake system (ABS) vehicle dynamics control (VDC) and/or Eyesight system.

Remedy

Dealer will replace the brake lamp switch.
