Recall #: C0367 | Auxiliary Carbon Canister Install Recall Date: 2019 Nov 18

Recall Description

Issue: On certain vehicles, the evaporative canister may have a defective sponge that is too short in length causing charcoal dislodging to occur. This may reduce the effectiveness of the canister and result in emissions exceeding the prescribed standards. Corrective measures: Dealers will install an auxiliary canister on all affected vehicles.

Recall #: R0181 | Engine Control Module Reprogramming Recall Date: 2021 Sep 13

Recall Description

Issue: Hyundai Auto Canada is conducting a Product Improvement Campaign that provides an update to the engine control module to detect potential problems before an engine fails. An engine failure would cause a sudden loss of power with an inability to restart. Note: This only affects vehicles equipped with a 2.4 L MPI engine. For the Sonata model, only the Sonata Hybrid is affected by this campaign. All vehicles previously included in TC # 2021-033 are now part of this new campaign. Vehicles that were previously repaired under campaign R0181 (Transport Canada #2021-033) do not require this software update. Safety Risk: A sudden loss of engine power could increase the risk of an accident. An engine failure could also create the risk of a fire. Corrective Actions: The company will notify owners by mail. Owners will be instructed to take their vehicle to a dealer to update the software for the engine control module. Note: Hyundai recommends that you should always follow the correct vehicle maintenance schedule, which is printed in the Owner's Manual. If you experience unusual engine noise, reduced power, or a check engine/oil warning light, Hyundai advises you to immediately visit a Hyundai dealership to have your vehicle diagnosed.

Recall #: C0525 - LM | Underbody Corrosion Recall Date: 2023 Dec 04

Recall Description

Issue: Hyundai Auto Canada is conducting a Special Service Campaign that provides anti-corrosion treatment to certain underbody components. Over time, components under the vehicle, including brake lines could corrode. In extreme cases, a brake line could fail and leak. A brake fluid leak can result in reduced braking. Safety Risk: Reduced braking can cause an extended stopping distance and increase the risk of a crash. Corrective Actions: Hyundai will notify owners by mail and advise you to take your vehicle to a dealership to inspect the underbody, including the brake lines. The dealer will apply an anti-corrosion treatment to certain parts, and replace the brake lines if necessary.

Recall #: R0246-1 | Anti-lock Brake System (ABS) Module Recall Date: 2024 Apr 01

Recall Description

Issue: On certain vehicles, brake fluid could leak into the control module for the antilock brake system (ABS) and cause it to short circuit. Safety Risk: A short circuit could create a fire risk, even while the vehicle is parked and turned off. Corrective Actions: Hyundai Canada will notify owners by mail and advise you to take your vehicle to a dealership to replace the fuse for the ABS module. Hyundai Canada

recommends that you should park your vehicle outdoors and away from other vehicles or structures until the recall repairs have been completed.
