Open Recalls

Recall #: A222359300 | Hood Striker Corrosion Recall Date: 2022 Aug 25

Recall Description

General Motors has decided that a defect which relates to motor vehicle safety exists in certain 2013 – 2015 model year Chevrolet Spark and 2014 – 2015 model year Chevrolet Spark EV vehicles. The secondary hood latch lever in these vehicles may prematurely corrode at the pivot. If severely corroded, the secondary latch striker may become stuck out of position and fail to properly engage.

Remedy

Dealers will replace the hood striker assembly and hood latch assembly. Vehicles included in recall 14V593 that have not received the recall remedy will be administratively closed under the old recall number and moved under this recall campaign.
