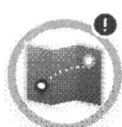

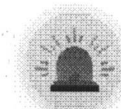

Recall #: RC082-A | On certain vehicles, the clockspring assembly for the drivers airbag may become damaged and fail. As a result the airbag may not function as intended, and the instrument panel warning lamp would illuminate. Failure of the drivers frontal airbag to deploy during a crash (where deployment is warranted) could increase the risk of personal injury to the seat occupant. Correction: Dealers will inspect and, if necessary, replace the airbag dockspring assembly.
