
How We Check for Liens

Recall #: TKC-20 | TAKATA FRONT PASSENGER AIR BAG Recall Date: 2020 Jan 02

Recall Description

This recall is for certain vehicles that had an airbag inflator replaced as a part of an earlier recall campaign. This recall provides a final repair. Long-term exposure to high absolute humidity and temperature combined with high temperature cycling may eventually degrade the propellant contained in the passenger-front airbag. This could cause the airbag to deploy with more force than normal. If the airbag inflator ruptures fragments could be propelled toward vehicle occupants or cause damage to the airbag assembly preventing its proper function.

Remedy

Owners will be notified by mail and instructed to take their vehicle to a dealer to inspect the passenger-front airbag inflator. The passengerfront airbag module or inflator will be replaced as necessary. Note: The Canadian climate results in the propellant degrading slowly. This recall is being conducted as a precaution to address future risk. It is expected that all airbag inflators will be replaced before their function would be affected.
