

Recall Description

Due to a production issue at the spring supplier, the front coil springs in certain Versa vehicles may have insufficient corrosion coating. In states where heavy concentrations of road salt are used in the winter, the front coil springs can develop corrosion over time. This can result in fracture of the spring. In the states listed below where there is heavy use of road salt in the winter and corrosion is likely to occur, the dealers will perform the remedy outline below: Connecticut, Delaware, District of Columbia, Illinois, Indiana, Iowa, Kentucky, Maine, Maryland, Massachusettes, Michigan, Minnesota, Missouri, New Hampshire, New Jersey, New York, Ohio, Pennsylvania, Rhode Island, Vermont, West Virginia, Wisconsin.
