#### Recall Description

AN INTERMITTENT ELECTRICAL CONNECTION CAUSED BY QUALITY ISSUES PERTAINING TO CONFORMAL COAT CONTAMINATION AND RIBBON CABLE PIN MISALIGNMENT WITHIN THE STEERING GEAR MOTOR MAY LEAD TO A LOSS OF THE MOTOR POSITION SENSOR SIGNAL THAT MAY RESULT IN LOSS OF POWER STEERING ASSIST. FORD IS AWARE OF 16 ACCIDENT ALLEGATIONS AND THREE INJURY ALLEGATIONS RELATED TO THIS CONDITION IN THE VEHICLES INCLUDED IN THIS FIELD ACTION. MOST OF THE ACCIDENT ALLEGATIONS REPORT THAT MINOR VEHICLE DAMAGE WAS INCURRED, TYPICALLY EITHER WHEEL DAMAGE RESULTING FROM CONTACT WITH A CURB OR MINOR BODY DAMAGE. THE INJURY ALLEGATIONS WERE ALL REPORTED AS MINOR WITH NO INDICATION THAT MEDICAL ATTENTION WAS SOUGHT FOR ANY OF THE INJURIES.

FORD MOTOR COMPANY HAS AUTHORIZED YOUR DEALER TO UPDATE THE POWER STEERING CONTROL MODULE TO PREVENT LOSS OF

STEERING ASSIST WHILE DRIVING DUE TO A MOTOR POSITION SENSOR FAULT.
