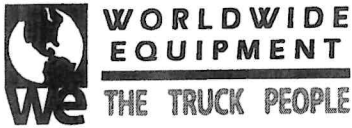

Reference: Bulk Registration Warranty Waiver for FERGUSON FOREST PRODUCTS INC

This form confirms FERGUSON FOREST PRODUCTS INC request for a waiver of Kenworth's requirement for each Warranty Agreement to be signed by the customer. Kenworth's standard policy requires the Warranty Agreements for each chassis to be signed by the customer at the time of the purchase transaction. Because FERGUSON FOREST PRODUCTS INC has purchased a large volume of trucks from Kenworth and believes it would be burdensome or repetitive to sign each truck's Warranty Agreement, FERGUSON FOREST PRODUCTS INC has requested a waiver of Kenworth's policy to sign each Warranty Agreement. Kenworth is willing to accommodate FERGUSON FOREST PRODUCTS INC request subject to FERGUSON FOREST PRODUCTS INC agreement to the conditions set forth below.

1. All provisions and conditions as stated in the Kenworth Warranty Agreement(s) in effect at the date of this waiver shall apply regardless whether the Warranty Agreement for a specific vehicle purchased bears the customer's signature.
2. The inception date for coverage under the Warranty Agreement(s) shall be the date the customer takes delivery of the truck and the Dealership sends the Bulk Registration documentation and waiver to Kenworth.
3. The Warranty Agreement is part of the individual truck purchase transaction and forms the basis of the bargain, regardless whether the Warranty Agreement containing the vehicle identification number bears the customer's signature.

This agreement must be signed by the customer in order to be effective. Once executed, the agreement shall apply to all new Kenworth vehicles purchased by FERGUSON FOREST PRODUCTS INC. The dealer shall include a copy of the signed agreement in all warranty registration submissions for the customer's fleet.
